Scope of Service may include:</p> <ul style="list-style-type: none"> • Provides patient and family education • Utilizes equipment to perform apheresis treatments • Provides patient care during apheresis procedures which may include: <ul style="list-style-type: none"> ○ Medication administration per physician orders pertaining to apheresis ○ Patient assessment and vital sign monitoring during procedures ○ Waived testing as defined by the facility ○ Participation in patient consent process ○ Coordination of care with other disciplines • Maintains and secures patient data and records • Documents care provided and procedure performed in the medical record as defined by facility policy • Demonstrates Clinical and Service excellence behaviors to include code of HCA Healthcare conduct core fundamentals in daily interactions with patients, families, co-workers and physicians.
