#### Anesthesia Technician:

The Anesthesia Technician must have equivalent qualifications, competence and function in the same role as employed individuals performing the same or similar services at the facility, as defined by facility job description.

#### **Definition of Care or Service:**

The Anesthesia Technician is a trained individual that has knowledge of the supplies, medications and equipment needed to provide anesthesia to surgical patients. This individual proactively ensures maintaining proper stock levels of anesthesia supplies, ensure carts are stocked for immediate use for operative procedures, cleaning and storage of equipment (before, during, and after anesthesia), & troubleshooting and ensuring equipment operation and maintenance. Scope of Service may include:

- Support anesthesiologists, anesthesiologist assistants, nurses and other members of anesthesia care teams.
- Clean, sterilize, test, calibrate and troubleshoot anesthesia equipment, as well as keeping records of equipment inspections
- Demonstrates Clinical and Service excellence behaviors to include code of HCA Healthcare conduct core fundamentals in daily interactions with patients, families, co-workers and physicians.

- Clean, sterilize, disinfect, stock, order and maintain the routine anesthesia equipment and supplies
- Provides support for routine surgical cases by assisting in the preparation and maintenance of patient equipment and anesthesia delivery systems before, during and after anesthesia
- Accurate patient information review and evaluation
- Uses at least two ways to identify patients before providing care or treatment
- Accesses the patient medical record appropriately and maintains confidentiality and privacy in accordance with HIPAA regulations.
- Documents in the medical record according to the facility standard / policy when appropriate
