<p>Armed Security Guard: The Armed Security Guard must have the equivalent qualifications and competencies as employed individuals performing the same or similar services at the facility.</p>
<p>Definition of Care or Service: The Armed Security Guard provides excellent customer service for the patients, visitors, and employees of the healthcare facility. They also provide a safe environment in the protection and services to healthcare patients, visitors, employees, medical staff, tenants and all other persons on the hospital campus. Security guard utilize a systematic integration of personnel, technology and proactive and reactive programs. Armed guard consists of carrying and the use of a self-defense weapon such as a taser or handgun. Scope of Service may include:</p> <ul style="list-style-type: none"> • Provides assistance to customers, employees and visitors in a courteous and professional manner. • Makes routine and random patrols of the hospital buildings and grounds • Maintains daily log, documenting unusual activities during shift including unlocking secured areas after business hours. • Performs security patrols of designated areas on foot or in vehicle • Watches for irregular or unusual conditions that may create security concerns or safety hazards. • Investigates and prepares reports on accidents, incidents, and suspicious activities. Maintains written logs as required by the post.

 - **Armed and Unarmed** – Can work while Private Security Service Registration and Firearm Endorsement is being processed.
 - G4S will provide a Licensure Waiver Letter.
→ *Set expiration to 120 days from date of the letter.*
 - G4S will provide Final paperwork for the working card (can be after or during the 120 days).
→ The final Guard Card will have the following that we need to track:
 1. Registration Date
 2. Firearms Date
- **New Hampshire:** State license
 - The license from New Hampshire’s Department of Safety must list the current employer on it.
 - If a different employer is listed we can provide a 45 day grace period once we receive the below:
 - A completed State of New Hampshire application for Security Guard license
 - A receipt with the payment date

Other Requirements:

- This position requires an individual to be able to stay on his or her feet for eight consecutive hours, walk long distances up to five miles per day, climb four flights of stairs and have the physical strength to confront whatever situation is unfolding, and the ability to lift up to 50 pounds.
- Only HCA Healthcare approved firearms, and OC pepper gel may be carried as duty weapons on HCA Healthcare property by guards certified to carry the specific weapons.
- Armed security guards are allowed to carry firearms that they have successfully completed firearms qualification training.
- Authorized duty holsters must have a minimum Level II retention capability.
- Only hollow point ammunition is approved. Absolutely no reloads, remanufactured, alterations or modifications of any kind to ammunition is permitted.
