<p>Post Op Nurse: The Post Op Nurse must have equivalent qualifications, competence and function in the same role as employed individuals performing the same or similar services at the facility, as defined by facility job description.</p>
<p>Definition of Care or Service: The Post Op Nurse works with Surgeons, Anesthesiologists, and Surgical staff to provide intensive care to patients as they awaken from anesthesia after a surgical procedure. Scope of service may include:</p> <ul style="list-style-type: none"> • Evaluates the patient’s condition and assesses when they are ready to move to the post-anesthesia care unit • Able to answer questions patients or family members have and verifies they’re prepared for the surgery and for the after-effects of general anesthesia • Provides ongoing assessment through observation of patient and records and reports findings accurately and on time to surgeon and/or anesthesiologist • Evaluate patients before and after the patient wakes up from anesthesia • Monitor patient’s condition to ensure patient remains stable and comfortable. • Demonstrates effective communication and collaboration skills with members of the perioperative team and other stakeholders. • Demonstrates Clinical and Service excellence behaviors to include code of HCA Healthcare conduct core fundamentals in daily interactions with patients, families, co-workers and physicians.
<p>Setting(s):</p> <ul style="list-style-type: none"> • Surgical services areas including but not limited to hospitals and outpatient surgery centers.

 - Participates in the pre-procedure process to verify the correct procedure, for the correct patient, at the correct site / side and involves the patient in the verification process when possible.
 - Participates in a time-out immediately before the start of an invasive procedure

 - Practices consistent hand hygiene
 - Uses personal protective equipment (PPE) when required
 - Required immunizations per Division requirements
 - Complies with Isolation precautions
 - Maintains sterile field
